Committee Composition	The Audit & Finance Committee is composed of a Chair (Secretary/Treasurer), one (1) Second or Third Year NAMSS Director at Large and four (4) NAMSS members who do not currently serve on the NAMSS Board.  The Executive Director and Finance/Accounting Director serve as advisors.
Membership Term	The Chair's term coincides with their term as Secretary/Treasurer of NAMSS. All other committee members serve a one (1) year term and are eligible for reappointment for up to two additional terms (up to three years of service). Terms run January 1 <sup>st</sup> – December 31 <sup>st</sup>
Expected Commitment	Time commitment expected for this Committee is 1-2 hours/month including conference calls. Conference calls are held quarterly.
Selection/ Appointment	Please refer to the Nomination of Board Members policy and Secretary/Treasurer job description for appointment of the Audit &Finance Committee Chair. All other members are selected by the President Elect with input from the Committee Chair. Committee member selections are approved by the Board.
